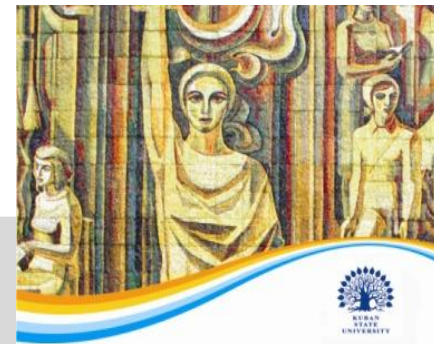
Values of the Programme :
